- 10. Dealing with domestic disputes
- 11. Dealing with verbal and physical abuse of the officer, including taunts, insults, and threats to the officer, family members, or fellow police officers.
- 12. Communicate effectively with individuals suffering from trauma
- 13. Operate a motor vehicle for long periods of time and in all types of hazardous conditions
