Chairman Walker asked Mrs. Cortileso, to review the correspondence from the month.

ROAD REPORT -

Supervisor Slahtovsky reported most of the time was spent maintaining the winter equipment and spreading anti-skid and salt.

POLICE REPORT -

Chief Pate reported that the new speed limit signs on Greensburg Road have been installed along with the radar speed sign which he will leave through January. Chief Pate stated the cars are still moving pretty good along that stretch of Greensburg Road once the weather clears up, they will start enforcing the speeding issue. Chairman Walker asked about the No U-Turn sign. Pate stated the only complaint on that sign is the sign being installed. Pated reported there were 894 calls for 2024 which was high of those calls around 9.5% were State Police. Pate stated a lot of the State Police calls do get deferred and



they are told to call the department when they are back on duty. Pate stated that the taser training is up to date and this month they will complete first aid CPR training.

Paul Schwan, 831 Merwin Road, asked about the speed limit on Greensburg Road. Chief Pate stated in some areas the speed limit is still 55 mph and in the small section of Upper Burrell the speed limit is now 45 mph. This area does cover 6 different municipalities and 2 different counties. Mr. Schwan also stated that the trucks leaving the well site on Merwin Road do not stop they just go straight through. Pate stated he will talk with the security at the well site.

Michael Moore stated that he does recommend paying the first and final payment request to NorthRock Construction for \$29,500.00, this project will be paid for by Westmoreland County CDBG grant funds.
